# Minutes of a meeting held on Tuesday 13<sup>th</sup> November 2018 in the Village Hall

[2018/11/1] The **Minutes** of the meeting held on 9<sup>th</sup> October 2018 which had been circulated were approved and signed.

[2] Snow Warden Scheme. Mr W. Jones was willing to continue as snow warden although he had to prioritise work on his own farm. He was willing to distribute salt to others. The council approved this and an order of another half-ton of salt.

[3] Highways. A new traffic survey was to be taken on the A377 where there a problem of speeding through Morchard Road. Some of the hedges had been trimmed and it was hoped that Network Rail would continue the work. Lorries were still being pushed into the middle of the road. The drains on Barn Hill need to be checked every three months. It was not clear if this was the responsibility of Devon Highways or of the landowner.

[4] New Bus Shelter [Morchard Road]. A grant was obtained from the "Communities Together" Fund. Mr L. Denno showed local designs based on a cruck frame. This would be in timber with a traditional Devon tin roof. Other possibilities were suggested including a polycarbonate roof, a reduced monopitch. It was important to consider the visibility at that location. The design to be reconsidered over the next fortnight.

[5] Village Hall. Christmas Event was scheduled for 15<sup>th</sup> December. Mr Tucker agreed to sink a pipe into the green for the Christmas tree. The finances were solvent.

[6] Village Green. One of the buses on the green had been removed. The other one does not obstruct the defibrillator.

[7] Defibrillators. The signs were to be installed.
