Tree hazards identified in 2017 assessment all attended to. Injury to volunteers or contractors working at arboretum	Severe	Could arise through maintenance operations or during warden duties	Moderate	Public liability insurance; policy of volunteers not carrying out hazardous operations such as chain sawing unless appropriate certificate; appropriate guards on equipment; briefing of volunteers on hazards both when they start to help in the Arboretum and when participating in Working Parties; require contractors to have appropriate insurance and certification and obtain and retain copies of insurance certificates from contractors before they do first work in Arboretum.  A notice is put up on the gate when volunteers or contractors are doing tree works instructing that dogs be kept on leads at that time	
Damage to property in arboretum and property owned by Friends	Severe	Most likely to arise from vandalism. Summer house is particular target, but tables, seats and trees could also be a target	Moderate	Summer house fenced off; prohibition of fires and barbecues; arboretum billed as only open during daylight hours; volunteer wardens make inspection of arboretum to deter vandals. Equipment owned by Friends kept in secure storage.	
Damage to church yard	Severe	Signing access through path at edge of churchyard	Low	Brief volunteer wardens to check all is ok and to inform Head Warden of any problems
