NOTICE OF CONFIRMATION OF AN ORDER

HIGHWAYS ACT 1980 WILDLIFE AND COUNTRYSIDE ACT 1981 DEVON COUNTY COUNCIL (FOOTPATH NOS. 2 AND 19, WITHERIDGE) PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2015

On 25th June 2015 Devon County Council confirmed the above order made under Section 119 of the Highways Act 1980 and Section 53A(2) of the Wildlife and Countryside Act 1981.

The effect of the order as confirmed is to divert part of Public Footpath No. 2, Witheridge from a line running north-eastwards to the south east side of Cannington Farm to a line running eastwards further to the east of Cannington Farm, as shown on the order map. It will also divert the remainder of Public Footpath No. 2, Witheridge and all of Public Footpath No. 19, Witheridge from a line running generally eastwards past Coombe Farm and through Cannington Farm's yard to a line northeast of Cannington Farm, running near to the south-western edge of Witheridge.

A copy of the order as confirmed and the order map have been placed and may be seen free of charge at the offices of North Devon Council, Civic Centre, Barnstaple, EX31 1EA from 9.00am to 4.00pm, Monday to Friday, or on request to the Clerk to the Parish Council. Copies of the order and map may be bought from the address below at the price of £5.00.

The order comes into force on 30th July 2015, but if a person aggrieved by the order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980 as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from the date of this notice, make an application to the High Court.

HIGHWAYS ACT 1980 WILDLIFE AND COUNTRYSIDE ACT 1981 DEVON COUNTY COUNCIL (FOOTPATH NOS. 2 AND 19, WITHERIDGE) PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2015

HIS ORDER is made by Devon County ("the authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this order and the public and the public it is expedient that the lines of the paths should be diverted.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the County of Devon definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses which are incurred in bringing the new site of the paths into a fit condition for use by the public.

North Devon Council has been consulted concerning the making of the order as required by Section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public rights of way over the land situate at Cannington Farm in the Parish of Witheridge in the County of Devon and shown by bold continuous lines on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 28 days from the date of confirmation of this order, and thereupon the County of Devon definitive map shall be modified by deleting from it those public rights of way, provided that this paragraph shall not come into force until the authority certifies that work required to bring the footpaths described in Part 2 of the Schedule into a fit condition for use by the public has been carried out.

2. Notwithstanding this order, where immediately before the date on which the paths are diverted in pursuance of this order there is apparatus on under or over the paths belonging to the statutory undertakers for the purpose of carrying out their undertaking then such undertakers shall continue to have the same rights in respect of their apparatus as they would have had if this order had never been made.

- 3. There shall at the end of 28 days from the date of confirmation of this order be public footpaths over the land situate at Cannington Farm in the Parish of Witheridge in the County of Devon described in Part 2 of the Schedule and shown by bold broken lines on the map contained in this order, and thereupon the County of Devon definitive map shall be modified by adding those paths to it.
- 3A. The County of Devon definitive statement shall be modified as described in Part 4 of the Schedule to this order.
- 4. The rights conferred on the public under this order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.





Footpath No. 2, Witheridge

From: Footpath No. 4, Thelbridge

To: Footpath No. 1, Witheridge

The path is a Footpath. It starts at its junction with Footpath No. 4, Thelbridge on the Thelbridge – Witheridge parish boundary to the south of Cannington Farm and proceeds northwards through a pedestrian gate then turns sharply eastwards and east-northeastwards following the southern field boundary, through a pedestrian gate and over a culvert and through a field gate. It then continues eastwards across a field and through a field gate and then continues east-northeastwards across a field to its junction with Footpath No. 1, Witheridge. It has a width of 2 metres and a length of 440 metres.

Footpath No. 19, Witheridge

From: C555 Drayford Road / West Street

To: Footpath Nos. 1 and 4, Witheridge

The path is a Footpath. It starts at its junction with the C555 Drayford Road / West Street to the north-northeast of Cannington Farm and proceeds through two field gates east-southeastwards and then eastwards along the southwest edge of a plantation and through a pedestrian gate to its junction with Footpath Nos. 1 and 4, Witheridge to the south of Wiriga Way. It has a width of 2 metres and a length of 440 metres.


