Applications for grant for 2019-2020 can be submitted until 5pm on 31 January 2020. This means the last date for completing an Expression of Interest form for a grant application is 5pm on 30 January 2020 (applicants will still need to complete their application form by 5pm on the 31 January 2020). Expenditure through a grant must be completed on or before 31 March 2020.

#### **Armed Forces Day**

Grants of up to £5,000 are available for events that are organised within two weeks of the Armed Forces Day on Saturday 27th June 2020 (20th June 2020 – 5th July 2020). To be eligible events must have "Armed Forces" in the title, be relevant to today's serving armed forces, have free access to members of the armed forces family, and must not be centred around fundraising or recruitment.

Events can include for example: Picnic in the park, Themed BBQ, Street party, Fête.



Grants can be used to pay for road closures, decorations, flags and banners, newspaper and radio advertisements, marshalling, security and first aid arrangements, insurance, PA and communications systems. The funding is being provided by the ! Ministry of Defence and offers a grant for Armed Forces Day events up to the value of ARMED FORCES DAY £10,000, depending on the size and format of the event.

This grant is match-funded and can cover up to half the total cost of the event. For details on how to apply, events must first be registered on the Armed Forces Day website. Deadline: 27 March 2020.

## **SportEngland**

Sports clubs, local authorities, schools and community organisations can apply for grants of between £1,000 and £150,000 to enhance local sports and recreational facilities.

The funding which is being provided through Sport England's Community Asset Fund can be used to enhance traditional sports facilities as well as outdoor spaces like canal towpaths, woodlands and open spaces; etc that can be used as part of an active lifestyle.

Statutory bodies and education establishments will specifically need to: ~Provide a minimum of pound -for-pound partnership funding; ~Demonstrate the strategic need for their project proportionate to the scale of investment requested;~Limit requests to a maximum of £150,000 within any 12-month period.

Sport England typically expect their awards to be either:



Small-scale investments typically ranging from £1,000 to £15,000. These will address emergency works due to something like storm or flood damage, or something totally unexpected that is stopping people from being able to stay active right now.

Medium-scale investments typically ranging from between £15,000 to £50,000. These will address more substantial changes. This might be an upgrade to an existing facility or developing a new space in the community.

By exception, Sport England will consider larger investments ranging from £50,000 to £150,000. This will be when organisations can demonstrate a considerable impact or are targeting under-represented groups. They are also unlikely to have received funding from Sport England previously.

Projects that run an all-or-nothing crowdfund on Crowdfunder and reach 100% of their funding target can unlock extra funding from one of the Crowdfund Devon partners.



#### Clothworkers' Foundation

The Foundation makes grants to charities registered in the UK, CICs, and other UK not-for-profit organisations including special schools through its Open Programme. The grants are for capital projects such as buildings, equipment and vehicles and should fit with one or more of the Foundation's programme areas: ~Alcohol and substance misuse ~Disadvantaged minority communities ~Disadvantaged young people ~Domestic and sexual abuse ~Homelessness ~Older people ~People with disabilities ~Prisoners and ex-offenders ~Visual impairment

Grants are made to large and small projects. Applicants are asked not to request a specific amount from the Clothworkers' Foundation: projects over £100,000 may receive around 10% of the balance to be raised; smaller projects with a balance of less than £10,000 may receive between 50% and 100% of the balance.

## **Arts Council England**

The V&A Purchase Fund has been renewed until 2022. Accredited museums, specialist libraries and record repositories accredited under the Archive Service Accreditation Scheme can now apply for a share of the £724,000 of funding available this year.

The fund enables regional museums and cultural organisations to strengthen the quality, relevance and standard of their permanent collections and supports the purchase of a wide range of material for the permanent collections of organisations in England and Wales. The purchase price of an object should be between £500 and £500,000 with grants available for up to 50% of the purchase price, though it is unlikely that any organisation will receive more than £50,000 in any one year.

#### **True Colours Trust**

Breathing Spaces Fund is to improve parent/carer rooms in hospitals. For the purpose of this programme a parent/carer room is defined as 'a non-clinical space within a hospital set aside for the exclusive use of the parents and carers of a paediatric patient. It should create a 'home from home' environment but is not overnight accommodation'.

Eligible hospital charities where the hospital has a PICU (wards specialising in the assessment and comprehensive treatment of children with a broad spectrum of acute and enduring mental health needs) can apply for grants of up to £20,000 to renovate or create parent/carer rooms on any inpatient paediatric ward. Applicants may request up to £1,500 in advance towards the costs of designing a parent/carer room in line with the Breathing Spaces guidelines, this sum will be deducted from the total £20,000 grant available. Any changes to parent/carer rooms funded by Breathing Spaces must be sustained and maintained for a minimum of five years and 10% of each grant should be ring-fenced for annual maintenance costs.

~Young People's Mental Health ~Arts as a Tool to Achieve Social Change ~Improved Quality of Life for Carers and for Older People. They fund charitable and not-for-profit organisations and target their funding towards issues and organisations which do not enjoy widespread public support.

They will consider funding salaries and project costs for up to three years. They do consider grants towards an organisation's core costs but they only tend to award these when an organisation is making a step-change in the way that it works or tackles a particular issue and where a core grant will provide greater flexibility during the transition period. The grants typically fall in the range of £10,000 - £20,000 per annum for up to three years.

#### **Edward Gostling Foundation**

Registered charities, Hospices and state schools catering wholly for students with additional needs, can apply for grants to support their work that enhances the quality of life for people in need, specifically the mentally and physically disabled. Priority is given to small and medium size charities making a significant impact in their community and who may lack the time and resources to be able to focus on their fundraising.

The Foundation's grants are awarded to projects that have a significant impact across one or more of four life "themes" and priority is given to organisations that clearly demonstrate this within their application for grant funding, these are: Health and Wellbeing; Independent Living at Home; Respite; and Transition. Grants can support:

- Modifications to homes, state schools (wholly for students with additional needs), hospices etc
- The provision of specialist equipment such as the provision of specialised wheelchairs, other mobility aids and equipment including medical equipment to assist independent living
- Financial assistance towards the cost of short-term respite breaks at a registered respite centre.

Grants are awarded through two programmes:



- A fast-track Small Grants Programme for applications under £5,000
- A Large Grants Programme for applications of £5,000 or over.

## **Joseph Rowntree Charitable Trust**

The Trust (JRCT) is interested in funding work which is about removing problems through radical solutions, and not simply about making problems easier to live with; that has a clear sense of objectives, and of how to achieve them; and is innovative and imaginative and where the grant has a good chance of making a difference. JCRT makes grants to a range of organisations including registered, excepted or exempt charities based in the UK for work that seeks to make positive change structures and systems that may deny them their rights.



Whilst the focus is to support national advocacy and campaigning, JRCT is open to applications which aim to effect structural change at local and regional levels of policy-making, provided the applicant can demonstrate the wider significance of the work.

Across the policy, JRCT places an emphasis on supporting those who have direct experience of racism and oppression.

Applicants are encouraged to apply for a grant for unrestricted or core support, although support for specific programme or project funding is also available.

The grants support the care and preservation of war memorials to a high standard, and to prevent the decay of this important part of our built heritage. Grants will normally be for up to a maximum of 75% of eligible costs, with a maximum grant of £30,000.

The fund is open to anyone to apply; individuals or organisations, including councils.

#### **Allen Lane Foundation**

Social Cohesion Programme, provides funding to support local communities in breaking down barriers and reduce tensions between different groups of people, and help to build a more cohesive and inclusive community. The aim of the funding is to:

- Proactively work towards building better community cohesion and trust, and encouraging respect and understanding in the local area
- Proactively promote the inclusion of marginalised groups and individuals in the life of the local community
- Fund work which breaks down barriers and tensions in the local community thereby reducing feelings of division and "them and us".

The Foundation is seeking applications from community-led grassroots groups and organisations which have a focus of work being at a very local/community level, which could be a housing estate or distinct community. The Foundation is particularly concerned about divisions in communities that occurred around the 2016 Referendum and subsequently.

Applications will be particularly encouraged from areas of high deprivation but not exclusively and the Foundation is keen to support communities in coming up with their own solutions to local issues of division. New initiatives, those that may have been tried before or are on-going, are considered as long as the work has lasting benefits for those people the projects are aimed at.

No minimum or maximum grant levels are published. In 2018, of the 153 grants awarded 112 were single grants with the remainder being for two or three years. The majority ranged from £750 to £15,000 with recipients including:

- Shelley Over 60's Club £4,000
- South Tyneside Prison Matters £1,000
- Manchester Refuge Support network £9,935

Applications may be submitted at any time.



Potential applicants need to check their eligibility. Once this has been confirmed they will be directed to the application form.

#### **Trusthouse Charitable Foundation**

The Foundation is offering Community Centres in deprived urban communities and Village Halls in remote and economically deprived rural areas the opportunity to apply for capital grants of between £7,500 and £60,000. All applicants must have secured 50% of the total cost of the work and have local community fundraising underway. #### **Woodland Trust**

The Trust has thousands of free tree packs to give away to community groups and schools. The trees are available for planting on an area that is accessible to the public so that it can be used and enjoyed by others. If applying as a school, trees should be planted on either the school grounds, land the school has arranged regular access to or in an area that is publicly accessible.

Applications for a tree pack for a community group need to:

- State that the land is accessible to the public
- Make sure the community is aware of the plans to plant and is happy for the project to go ahead.
- Be an application for up to 420 trees in each application cycle or season.

There are two delivery periods per year in November and March, when the trees are dormant and perfect for planting. Tree packs can consist of:

- Hedging to make a natural screen or connect existing woodland to help wildlife stay on the move
- Copse to create a mini forest school classroom or a peaceful spot that's an oasis for birds
- Wild harvest an array of fruits and nuts
- Year-round colour for beautiful blossoms, bright berries and stunning autumn displays
- Working wood to fuel a log burner in 7-10 years, or to carve or weave willow
- Wildwood to establish food and shelter for wildlife
- Urban trees for residential areas with limited communal space

Applications are currently being accepted for trees to be delivered in March 2020.

## **Rowing Foundation**

The Foundation gives grants of £500-£3,000 to help organisations and clubs involved in on water elements of the sport of Rowing who are individually affiliated to British Rowing (other than via their governing body) and whose requirements may be too small or who may be otherwise ineligible for an approach to the National Lottery or other similar sources of funds. The Rowing Foundation prefers to encourage participation in rowing by the young or disabled through the provision of equipment, such as boats, sculls, ergos, oars and essential safety equipment.

The Foundation's makes grants of between £500-£3000 up to 50% of the cost, usually to initiate projects when a club, school or other organisation can demonstrate their ability to complete the project. Grants are made to support rowing only.

Applications must be for projects or work that is for public benefit; non-elitist; for the benefit of young people; those in full time education; or those who are disabled.
