PRESENT: - Cllr Sheldrick (Chairman), Cllr Norton, Cllr Meads, Cllr Denton, Cllr Lancellas, Cllr Skinner, CCllr Margaret Squires, DCllr Polly Colthorpe. Members of the public: - Mr William Metcalf, Ms Elly Babbedge

1. PARISHIONERS QUESTIONS AND STATEMENTS: - Ms Babbedge, gave an update on the community shop as below:

Cheriton Fitzpaine Community Shop update 16.1.17:

Elly Babbedge and David Plumridge had a meeting with the Parish Hall committee booked on November 15th to discuss the siting of the shop kabin on the PH car-park. This meeting was changed to "PHC Committee only" in order to vote in new leadership. Understandable. EB and DP were offered Dec. 1st instead. On November 28th, we learnt from another source that the PHC meeting was now a "closed" meeting, and rescheduled for December 5th. Having received no confirmation, we had to check that the Dec. 1st meeting had been cancelled.

On Dec. 5th, the PHC met and voted against siting the kabin on the car-park on account of its size. This had a number of implications:

- 1. The business plan worked out over the previous 3 months was brought to nothing.
- 2. An application for £10K funding from Viridor that had been prepared ready for application by 12th December had to be scrapped.
- 3. Pledges of financial support, that had produced £16K in the first 10 days dried up as news got out about the vote, as people said they would give once they knew what they were giving for.
- 4. Having lost three months work, it would take at least that to assess alternatives, and in the short-term the village would be without a shop.

Alternatives looked at since, include:

- 1. Timber-frame building, but all costs would need to be written off as there would be no resale or residual value.
- 2. A smaller kabin (at 30'x10' and priced at £5K) was priced up to include CCTV, alarm system, upgrade floor loadings and electrics, transport from York, air-conditioning/heating, fitting out with shelving, totalled £16,350, which didn't include chillers, freezers, or an exterior ramp for disabled access. Cost per square foot was nearly double that of the Kingsbury kabin.
- 3. Mobile shop: could be viable, and have a re-sale value, but would need to be sited in the village and have secure over-night parking. Only units the size of the current Pizza Van is available on-line at present, and they are too small. An existing mobile shop Service has been approached but has no additional availability and would need a £250 per day guarantee to justify a visit.
- 4. Rent the existing shop. Not available as currently being used for storage.
- 5. Use of the "barn" at the Half Moon. Not available.
- 6. Siting on the Surgery car-park. No access for an articulated lorry further than the church.
- 7. Skittle alley at the Ring of Bells. Needs a lot of expensive refurbishing, and the lease would be difficult. The Shop steering group are currently exploring two possible options that could provide a long-term permanent village shop, but there are no immediate solutions to the need for a temporary shop. Newspaper delivery and collection started 17.1.17 from Binka's barn manned by volunteers, but need more volunteers
