4) **Village Green:** The Green was in need of some care. Suggestions included nice seating, possibly of stone, more trees. There needed to be work to protect the edges from erosion. The drainage at the bottom of the green needed to be replaced or improved. Work also needed to be done on the trees round the bus shelter. Repairs were also needed at the Morchard Road playground.
