

Certificate of Exemption – AGAR 2024/25 Form 2

 - issued a public interest report in respect of the authority or any entity connected with it
 - made a statutory recommendation to the authority, relating to the authority or any entity connected with it
 - issued an advisory notice under paragraph 1(1) of Schedule 8 to the Local Audit and Accountability Act 2014 ("the Act"), and has not withdrawn the notice
 - commenced judicial review proceedings under section 31(1) of the Act
 - made an application under section 28(1) of the Act for a declaration that an item of account is unlawful, and the application has not been withdrawn nor has the court refused to make the declaration
- The court has not declared an item of account unlawful after a person made an appeal under section 28(3) of the Act.

If the above statements apply and the authority neither received gross income, nor incurred gross expenditure, exceeding £25,000, then the Certificate of Exemption can be signed and a copy submitted to the external auditor **either** by email **or** by post (not both).

The Annual Internal Audit Report, Annual Governance Statement, Accounting Statements, an analysis of variances and the bank reconciliation plus the information required by Regulation 15 (2), Accounts and Audit Regulations 2015 including the period for the exercise of public rights still need to be fully completed and, along with a copy of this certificate, published on the authority website/webpage* before 1 July 2025.

Net 'other receipts' in the two years was therefore: 2023-4 = 20,039-20,234 = £305 and 2024-5: £2,106-1,931 = £175 giving net variance of £130, within the acceptable limits of £200.

Two items of one-off expenditure were made in 2024-5 - £738 for mounting an historic map and £412 for removal of dangerously decayed fences, giving a net payments total of £3,501-1,150 = £2,411. The resulting variance is £183, which is within the acceptable £200 limit.
