Minutes of a meeting held on Tuesday 8<sup>th</sup> April 2025 in the Village Hall

The Chairman reported the death of Mr F. Letch, Chairman of MDDC and husband of Mrs N. Letch. The Council expressed their sympathies.

[2] There were no disclosures.

[3] The **Minutes** of the meeting held on 11<sup>th</sup> March 2025 which had been circulated were approved and signed.

[4] There were no comments from members of the public.

[5] **Public Conveniences**: Mrs Cridland had not had any response from Mr Edwardes or Mr Densham. Discussions were continuing at MDDC.

[6] **Village Green: a)** Mr Leach had signed an amended contract. The first cut had been successful. The number of cuts would be variable.

Action Point: Clerk to notify Miss West that the weeds and overhanging branches would be cut back.

**b)** The application for access from Mr & Mrs Pluck was discussed The Council agreed that they would need to get planning permission from MDDC since there was a clause in the original approval that they had been granted stating that access would be onto the road to Bow. There was an objection that the gates to the Green being left open might lead to noise problems There was also a possibility of cars being parked on the Green. The Council decided to make no final decision until planning permission was being sought. Advice would be needed from planning, highways and environmental services.

[7] **Bus Shelter**: Work was prepared to start in October provided proper insurance cover was in place. Quotations for a wooden notice board were being sought.

Action Point: Application for a grant to be submitted.

[8] **Roads**: The road from Down St Mary to Zeal Monachorum had been repaired and seemed satisfactory. Barn Hill was beginning to sink in the middle.

Mrs Bennet hoped to arrange a first aid course in September.
