

MINUTES OF A MEETING OF BOW PARISH COUNCIL HELD ON 14 MAY 2025 AT 7:30PM

1. **To Elect Chairman.**

The Clerk called for nominations. Mr Nicks was proposed by Mr Vanstone and seconded by Mr Hamilton. Mr Nicks was willing to stand. Without any other nominations forthcoming and all being agreed, Mr Nicks was declared elected. The Declaration of Acceptance was completed and signed.

2. **To Elect Vice Chairman.**

Nominations for the post of Vice Chairman were invited. Mr Pengelly was nominated by Mr Hamilton and seconded by Mr Pocock. Mr Pengelly was willing to stand. Without any other nominations forthcoming and all being agreed, Mr Pengelly was declared elected.

Mr Vanstone, who had served as Vice Chairman for some years, did not wish to stand and indicated that he was seriously considering resigning from Parish Council. He submitted that Bow was a 'can do' village but also felt that it lacked support from higher authorities. He said that he had become a Parish Councillor and would have liked to have been able to make a difference but had become disillusioned as he felt that Parish Council had been stopped from doing good; examples were cited where Parish Council had been unable to achieve aims. He was not party political but had become tired of local and national government. He would write his letter of resignation.

12. **Annual Audit, Annual Governance and Accountability Return (AGAR) 2024-2025 Form 2**

The completed Certificate of Exemption had been signed and submitted to PKF Littlejohn LLP on 14 April (deadline 30 June 2025), it had also been published on Parish Council's website. Mr Weeks would undertake the internal independent audit which was currently being arranged. AGAR Form 2 Section 1 Annual Governance Statement required Parish Council completion and AGAR Form 2 Section 2 Accounting Statements required Parish Council approval after the Annual Internal Audit Report had been received. Bank Reconciliation pro forma had been completed by the Clerk/RFO. The Explanation of Variances had also been completed by the Clerk/RFO, the explanation for 'high' reserves: Box 7 (balance c/fwd) is more than twice Box 2 (annual precept) because the authority held the following breakdown of reserves at the year-end, would show Improve highway (A3072) safety, at western approach to Bow village – in consideration of possibility of installing lighting.

13. **V.A.T. For Year 2024-2025.**

A sum of £318.03 had been reclaimed online, by the Clerk, on 17 April 2025. HMR&C refund was awaited.

14. **Local Government Reorganisation, English Devolution White Paper.**

A recording, Youtube video, of DALC's Larger and Smaller Council meetings held 1 April and 8 April, was available. A copy of the Smaller Councils meeting had been circulated to Bow Parish Councillors. It comprised a brief recap of the limited information known at that point and opened for questions. Initial questions raised by the 13 parishes bordering Plymouth unitary authority regarded their possible dissolution – Plymouth proposed to 'stretch' into the South Hams to take on 13 parish councils and Ivybridge town council. Questions to DALC reference Plymouth's apparent 'land grab', referred to NALC who had issued legal advice – that parish councils are statutory bodies, would remain as such in perpetuity, that legislation would be necessary to abolish them and there wasn't any

indication of that. Other comments/questions included the creation of the Devon and Torbay Combined County Authority (DTCCA), that town/parish councillors would need to 'step up' regarding challenges ahead, that clerks would have more work/hours (with salary reviews) prompting questions on whether clerks needed an official qualification (CiLCA), with concerns expressed by small councils whether they could both recruit and afford a suitable clerk. Clerks to be mindful of any skills and training needed. It was said that town/parish councils should not expect assistance from district councils in the acceptance of devolved functions (leisure centres, play areas, etc). Towns/parishes needed to consider the Assets of their parishes – establish who owned it, decide what the parish wanted and how it could be managed and funded. If town/parish councils did not accept devolved functions, they would 'disappear'. Parish Council briefly considered MDDC owned Bow play areas – preferences, in terms of ownership, management, etc going forward required consideration. Similarly, grass verge trimming carried out by district councils needed checking as to responsibility and consideration.

15. D.C.C. Highways Matters.

Speeding A3072 western approach to village (DCC suggested highway works), Burston Cross area. Nothing had been heard/received from DCC.

Vehicle Activated Speed Sign (VAS). A response from Sir Mel Stride MP included DCC's comments to him, being "County Council officers have liaised with the Parish Council and local County Councillor on this matter. It was understood that they were exploring a joint purchase with a neighbouring community. The County Council is awaiting confirmation of this and details of the proposed location(s) for the sign for approval. It would appear that there has been a misunderstanding on this action, and Council officers will now contact the Parish Clerk to liaise and ensure the request progresses."

Some years previous, Parish Council had considered a shared/joint VAS acquisition but DCC was aware Parish Council was proceeding independently and the proposed locations for the VAS had been approved on 9 July 2024! To await DCC's contact.

Other Highway matters. No issues raised.
