When the Parish Plan was being prepared about a quarter of the respondents indicated that they are already involved in community-based voluntary service, but even more said that they would consider helping with community well-being initiatives, volunteer for local recreation groups or community safety and security initiatives if they were asked.

RED TELEPHONE BOXES

Parishioners should notice that the two telephone boxes, in the village and at the Station, have been repainted. The paint was provided by BT and the Parish Council paid to have them painted. Both boxes are now the property of the Parish Council and they cost the Parish £1 per telephone box.

New signs have been placed in the telephone boxes and the box at the Station is now a Book Swap Shop and has leaflets etc. in it. This box is maintained by Cllr Chris Southcott so any issues relating to it should be directed to Chris. If you take a book from those available please donate another one!

The box in the village should have within it (by the time you read this newsletter) the village defibrillator which will have been removed from the wall at the Crown & Sceptre. It is also hoped to have some books to swap and some leaflets. The defibrillator is being looked after by Geoff Jackson and the box itself and other contents by Tim Sedgwick.

The Parish Council are extremely grateful to Chris, Geoff and Tim for their ongoing support for these boxes.

ALLOTMENTS

The Parish Council still have a number of its allotments to rent and these are available at £20 per year.

The allotments are situated next to the current School and opposite Tytheing Close.

DOG FOULING

The ongoing problem of dog fouling continues to be a major issue for the Parish Council. There appear to be a few very irresponsible dog owners. The Parish Council have paid for the installation of 6 dog waste bins. These are situated in the following locations: by the river bridge in Station Road, entrance to Court Orchard by the main road, Tytheing Close, Sand Down Lane, Pump Street and West Town. In addition free dog poo bags are available from the Parish Council surgery table at the Coffee mornings on the first Saturday of the month.

The Parish Council are looking at what other legal steps it can take to deal with the few irresponsible owners. The Parish Council are appreciative of those responsible dog owners who deal with their dog's mess in the appropriate manner.

It is not acceptable to throw dog poo bags into the hedges and also dog mess should be picked up on the public footpaths. There is also a responsibility not to let dogs mess on agricultural land especially if there is livestock using those fields. PLEASE HELP
